  - c. The Berlin Initiative the German sponsored project regarding the Western Balkans` European integration process
- d. Regional cooperation between WB countries in the context of the EU enlargement
  - e. Initiatives for regional cooperation that could contribute to reconciliation between nations and states of WB
  - f. The policy of non-EU countries or actors towards the Western Balkans region and countries (select one of them)
  - g. What should be the role of Croatia, as a EU Member State, in the realisation of the EU policy towards WB 6
